In accordance with the pertinent provisions of RA 7722 otherwise known as the "Higher Education Act of 1994", and the responsibilities of the Commission outlined in Republic Act 10533 or the Enhanced Basic Education Act of 2013, CHED has created measures to address the impact of the full implementation of K to 12 on higher education institutions (HEIs).

Attendees are further requested to bring a copy of the transition plans, or the list of faculty and staff that they wish to nominate, draft copies of nomination templates and at least one laptop unit with Microsoft Office 2010 or higher version.

Morning snacks, lunch and afternoon snacks of the K to 12 Focal Person or his/her permanent alternate on April 11, 2016 will be shouldered by CHED, however other expenses shall be chargeable against local funds subject to the usual accounting and auditing rules.
